



IP Address Justification Form

As you may be aware, the internet is at a turning point and IPv4 IP addresses are a scarce resource, with a projected depletion for North America in 2015. Mean Servers is committed to ensuring the fair use of IP addresses among all clients in addition to complying with all ARIN guidelines for the use of this resource. In order to ensure the fair and proper usage of this resource, we are required by ARIN to collect the usage of these IP addresses via this justification form.

You have been temporarily approved for your usage of your currently assigned IP addresses; however, that permission will be revoked for failure to completely fill out this form in a timely manner or for use of these IP addresses inconsistent with ARIN's policies available on the web at <http://www.arin.net>.

You are hereby given notice that this form must be completed and submitted back to Mean Servers for approval within 2 business days. Failure to comply will result in the removal of your additional allocated IP addresses without refund. Furthermore, you understand that Mean Servers may remove your additional allocated IP addresses should Mean Servers not find you to use these IP addresses in accordance with ARIN policy or should you provide invalid justification for such usage.

Mean Servers expects 80% of IP addresses that have been ordered to be in use within 3 business days. Failure to use the 80% of the requested IP addresses within 3 business days constitutes a non-immediate use of IP addresses which will be cause for the removal of the unused space without refund. Mean Servers allows you to order additional IP addresses at any time, hoarding however, is strictly forbidden.

To help ensure IP addresses are only ordered when needed for services needed, Mean Servers has adopted the policy that additional IP addresses are exempt from recurring discounts. Additional IP addresses may be discounted only for their first invoice, whether the promotional code is recurring or not, at which point the discount will be removed for subsequent billing periods.
